Last year it was grazed but the Corncrake group who produced the management plan wanted to make the area into a Hay meadow but there are difficulties in finding interest in cutting this for hay due to a perceived dog mess issue. The Corncrake group will need to re look at the plan if a contractor cannot be found and consider a fence to protect the trees if the area is to be grazed.
